Purpose: the Witt Volunteer Fire Department Junior Firefighter program is designed to allow our community's youth to explore a potential career in the Fire Service. This program will teach participants basic firefighting skills, team building skills, and leadership skills. This program is demanding and rewarding to both our youth and veteran firefighters alike.

Basic Requirements:

- Jr. Firefighters must be between the ages of 14-18 years old.
- Jr. Firefighters must have completed a consent form.
- Jr. Firefighters must maintain a 2.2 G.P.A. (C+) in school.

Rules:

- Jr. Firefighters must attend 7 fire department functions per year.
- Jr. Firefighters must act in a manner befitting a public service official.
- Jr. Firefighters mush abide by the Witt Volunteer Fire Department Drug and Alcohol policy.

This document shall outline the rules and regulations which must be abided by as a junior member of the Witt Volunteer Fire Department.

- Meeting Attendance: Each junior firefighter shall attend meetings if he/she desires.
 There are no requirements for junior firefighter meeting attendance however it is strongly recommended.
- II. **Training Attendance:** Each junior firefighter shall attend a minimum of four (4) in house training events per year. Failure to achieve this standard could result in termination from the Fire Department.
- III. **Equipment:** Each firefighter shall be outfitted with the following equipment:
 - a. One set structural firefighting gear consisting of: boots, bunker pants, bunker coat, helmet, nomex, hood, and gloves.

Volunteering as a firefighter or emergency first responder for the City of Witt and surrounding community is a privilege that is earned. The WVFD strives to make every task and complete every action a positive experience in the eyes of the public by way of professionalism and compassion. Remember, each time we roll out of the fire station we are responding to someone in need.

- (A) I WAIVE, RELEASE, AND DISCHARGE from any and all liability, including but not limited to, liability arising from the negligence or fault of the entities of persons released, from my death, disability, personal injury, property damage, property theft, or actions of any kind which may hereafter occur to me including my traveling to and from this activity, THE FOLLOWING ENTITIES OR PERSONS: THE WITT VOLUNTEER FIRE DEPARTMENT AND THE CITY OF WITT.
- (B) INDEMNIFY, HOLD HARMLESS, AND PROMISE NOT TO SUE the entities or persons mentioned in this paragraph from any and all liabilities or claims made as a result of participation in this activity, whether caused by the negligence or release or otherwise.

I acknowledge that THE WVFD AND CITY OF WITT and their directors, officers, volunteers, representatives, and agents are NOT responsible for the errors, omissions, acts, or failures to act of any party or entity conducting a specific activity on their behalf.

The Accident Waiver and Release of Liability From shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law.
